

Tendable - Digital Accreditation

Pricing document

The price for your contract will be based on the following:

1. User numbers

Tendable sees quality assurance and improvement as everyone's job. Therefore we provide an enterprise license which makes no restriction on user numbers - all prices assume unlimited users within the organisation.

2. Organisation size:

We have banded pricing based on numbers of staff (whole time equivalent) to scale price proportionate to scale of organisation. These are listed on the table below.

3. Accreditation product

We have created a package of accreditation inspections, reports and collaboration tools to enable a high quality digital accreditation programme to be digitized and run.

Final pricing will be subject to a detailed assessment of the accreditation programme to ensure that the package is right-sized for your specific circumstances.

This may result in the price being adjusted to scale the inspection programme and audits price to match.

4. Audit levels

Additional non-accreditation focused inspections maybe wanted by the organisation and can be procured to run alongside the accreditation programme and on a modular topic by topic basis can be added to the purchased package.

Looking to run a comprehensive audit programme alongside Accreditation may result in your being moved to the Quality and Regulatory Compliance Manager and pricing plan to ensure best financial outcomes.

5. Product scope purchased.

Each product and module has a price for each band. These are listed on the table below. Each module price should be added to the core audit module (which must be purchased as the central element of the solution)

6. Service level

We have 2 service levels –

- Standard service – self-service in structure - included in the product prices.
- Enhanced service – Tendable advice, support and execution for all major configuration changes - a percentage uplift on over the standard... fewer bands (4-5 bands)

7. One off costs

Initial standard implementation charges are included in the license fees above. + 1 review and reconfiguration a year.

Implementation work over and above standard or additional frequency that that stated above will be charged subject to rate-card.

There will be charges for integrating Tendable into other local systems, such as EPR with price depending on number with custom integrations being charged according to the enclosed rate-card.

8. Ad hoc costs

Services and bespoke development outside of the purchased scope will charged according to the enclosed rate-card

9. Whole contract discounts

For high whole contract values there will be a total contract discount applicable

Service level

- Each module required (plus the core audit) should be added together to equal the annual standard service and product license cost.
- Enhanced service level price is the standard service price **plus 25%**.

Integrations

- For each approved integration there will be an annual charge of £2,000. Tendable will maintain and add to the list of approved integrations
- For each custom integration there will be an additional annual charge of £4,000

One off costs

- Each listed integration will incur an implementation charge of £3,000
- Each custom integration will be estimated and charged according to the attached rate-card.

Whole contract discounts

Discount criteria	Discount
For purchase of 2 modules on top of a full audit scope	5% of the full undiscounted contract price
For each additional module (ie. the 3 rd , 4 th , 5 th etc.)	An additional 5% of the full undiscounted contract price for each additional module. I.e 4 modules purchased will generate a total 15% discount of the whole undiscounted contract value.
For contract commitments of 4 years or more	10% of the full undiscounted contract price (additional to the module discounts)
