# PRICING MODEL

*How services are charged*

This service is delivered on a Time and Materials basis using qualified consultants at day rates defined in the accompanying SFIA Rate Card.

Engagements are scoped during initial discussions with the Buyer, with effort estimates provided based on project complexity, scale, and specific requirements.

## CONSULTANCY DAY RATES

### SFIA-Based Rate Card

Our pricing is aligned to the Skills Framework for the Information Age (SFIA) levels 1-7, providing transparent and consistent rates across all role types.

*Fixed price and outcome-based options*

## VOLUME DISCOUNTS

*Discounts for larger engagements*

## INCLUDED IN DAY RATES

*What is covered by standard rates*

- All travel, mileage, and subsistence within the M25 boundary
- Professional Indemnity Insurance
- Access to BetterGov project management tools and collaboration platforms
- Internal quality assurance and peer review
- Standard progress reporting and governance participation

## NOT INCLUDED

*Items chargeable separately*

- Travel, mileage, and subsistence outside the M25 (charged at Buyer's standard rates)
- Third-party software licences or subscriptions
- Hardware or infrastructure costs
- Out-of-hours support (available by arrangement at enhanced rates)
- Data extraction from legacy systems (quoted separately based on complexity)

## PAYMENT TERMS

*Invoicing and payment arrangements*

Invoices are submitted monthly in arrears based on days worked. Payment terms are 30 days from invoice date unless otherwise agreed in the Call-Off Contract.

## **In accordance with G-Cloud 15 Framework Schedule 3 (Framework Prices):**

- All prices are Maximum Prices which may be reduced (but not increased) during the Framework Contract Period
- Day rates do not include any uplift for risks or contingencies (para 5.3)
- Travel, mileage, and subsistence within the M25 is included in day rates (para 5.4.2)
- All prices exclude VAT
- Day rates are based on a 7.5 hour working day
- All prices are in GBP Sterling to two decimal places
