## Overview



Glider Nexus is a secure, cloud-based asset information management platform that enables the structured creation, validation, and long-term management of building information across the asset lifecycle. It extends this capability by connecting project and operational data into a single, structured and searchable source of truth, supporting effective digital handover and in-use asset intelligence.

Aligned with ISO 19650 and openBIM standards, Glider improves collaboration across supply chains, protects data integrity and enhances operational efficiency. The platform is designed to reduce risk, support compliance and ensure asset information is fit for operational use.

Glider is certified to ISO/IEC 27001, accredited to Cyber Essentials Plus and fully GDPR compliant, providing assurance that information is managed and protected to the highest security standards.

## 1. Introduction

This document provides pricing information for the software and services as included in the Glider Nexus Service Definition.

The pricing information in this document is provided as a guide for customers. Pricing will be tailored for each individual project based on the customer's requirements and Glider's scope of works.

## 2. Software licencing options

Glider Nexus licensing is estate-scale based, calculated on the total size of the managed estate in square feet.

The model is structured as follows:

### 2.1 Core Platform

The Glider Nexus platform's core functionality provides the foundational Common Data Environment (CDE) and essential functionality for asset information management.

Pricing is banded by estate size, with annual costs increasing by square footage tiers:

### 2.2 Optional Capabilities

## 2.3 Operational Modules

## 2.4 Glider Property Module

## 2.5 Additional Users

Additional named users can be purchased in blocks of 25 users. The base line cost is £6,000 and this is to be scaled by the same module multiplier outlined in section 2.1.

## 2.6 Integrations

Glider Nexus supports integration with third-party systems through a suite of API connectors and orchestration tools, enabling seamless data exchange across enterprise platforms. To activate API functionality, the API Mobilisation and Orchestration option is mandatory.
