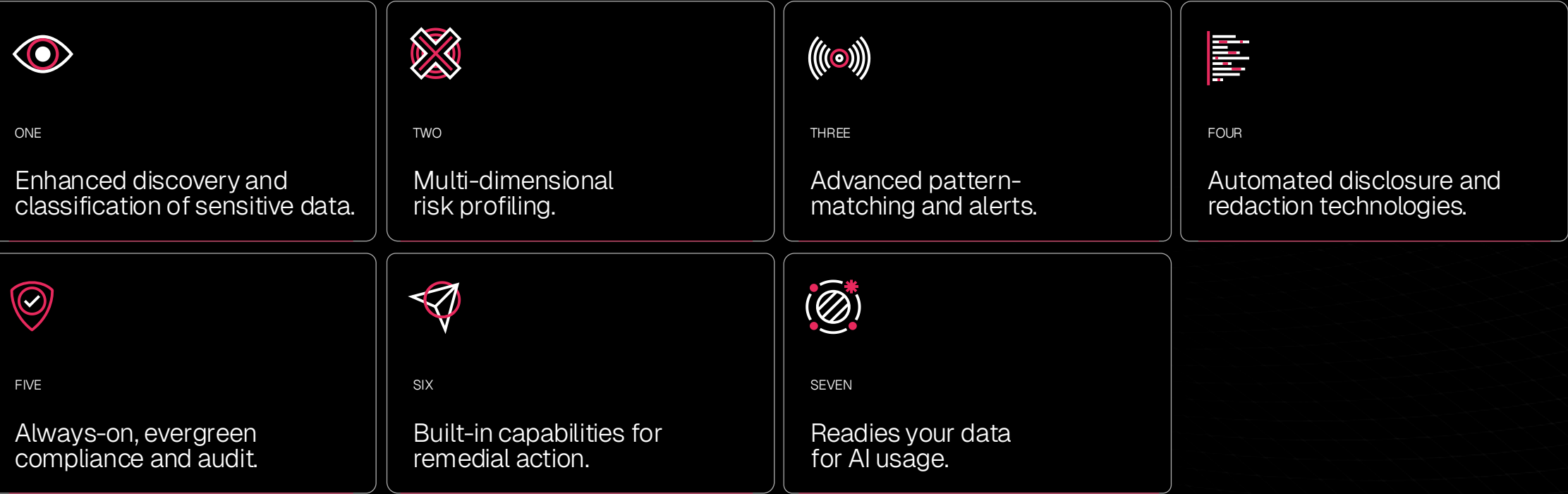

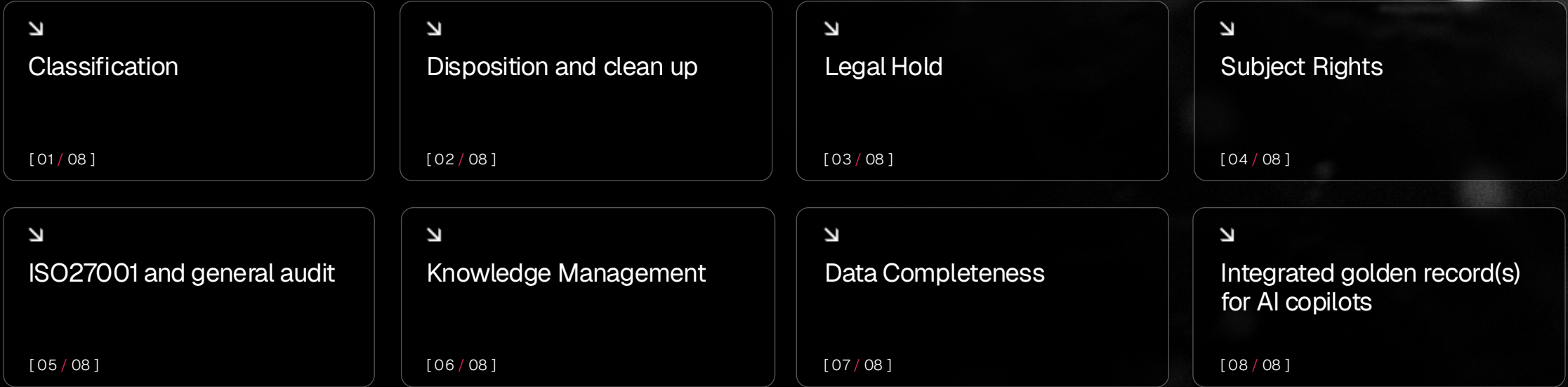

Platform Overview.



01 | DISCOVERY



Our software platform automatically crawls all repositories, whether they're in the Cloud or on-premises. This captures an up-to-date centralised index of everything that exists in any organisation, including its filename, metadata, where it's stored, and who can access it.

02 | ENRICHMENT



With no user involvement needed, the platform enriches information with additional context and structure, using machine learning techniques like classification, text extraction, geotagging, and named entity recognition. Our enrichment agents perform processes including: Optical Character Recognition (OCR), Natural Language Processing (NLP), Geotagging, Image Recognition, Speech-to-text, and Named Entity Recognition (NER).

03 | REPOSITORY



The repository layer stores the enriched information index, along with security information and other configuration data. It can house tens of billions of pieces of information yet gives users blisteringly-fast response times.

04 | GATEWAY



All information is secured with an authentication gateway which respects access permissions from source systems and integrates with any corporate security protocols, like multi-factor authentication and single sign-on.

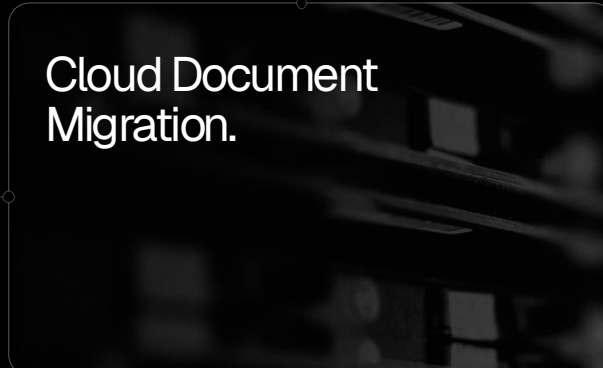
