1 Background

BECS is a suite of hosted services designed to enable Local Authorities and their trusted partners to channel shift complex transactions to the Web, take advantage of increased data accuracy and efficiencies, and widen access to their services.

2 Subscription Basis

All BECS services are supplied on an annual subscription basis which includes licencing, installation, onboarding, localisation, hosting, support and maintenance. Buyers subscribe to each BECS service they need for a term of not less than one year. Secure connections to and integration with EDMS, core Revenues & Benefits systems, customer portals, CRM, and other core systems, are handled as Change Requests that are chargeable at SFIA day rates on approval of a project plan covering the desired scale and scope of integration.

BECS services are not provided on a per-submission basis. Instead, each service adheres to a Service Level Agreement and Team Netsol contracts to provide an outcome to its clients in accordance with the defined service level. This enables clients to process as many applications as they wish without incurring additional costs and Team Netsol ensures that it has sufficient resources and capacity to meet the service levels irrespective of usage.

Each service attracts a Base Price and a Unit Price. The Base Price ensures that adequate capacity is available for the service and the Unit Price reflects the different support and hosting costs for different sized organisations.

The Unit Price is charged per Council Tax Chargeable Dwelling in the Local Authority (as identified in England via MHCLG's "Council Taxbase local authority level data" published in November, in Wales via StatsWales' "Council tax dwellings, by local authority" published in January, and in Scotland via Gov.Scot's "Chargeable Dwellings" published in September.)

3 BECS Change Pricing

BECS Change securely captures personal information in an intelligent, directed manner so that, a clean, valid change can be reported for locally-administered benefits and the necessary data and documents delivered automatically to the back office via standard integration APIs (**please note**: activated integration API licences must be separately procured from your back office system vendors). BECS Statistics provides a secure Web management interface for management information reporting for changes in circumstance and is included as part of BECS Change.

3.1 BECS RBV for CiC Pricing

BECS RBV for CiC provides automated risk scoring for reported changes and modifies evidence requirements accordingly (**please note**: requires a Risk Based Verification service, e.g. Xantura RBV Service, with appropriate API licence to be procured separately from a recognised RBV vendor).

7 Other Fees and Charges

7.1 Custom Development

Team Netsol has a single, consolidated day rate for provision of development and implementation services for the purchased product packages (within the UK mainland) of £970 per person per day, exclusive of any applicable travel and accommodation expenses.

Team Netsol has a single, consolidated day rate for provision of services for design, and consultancy for bespoke solutions, of £570 per day.

Consultant working hours are from 09.00 to 17.00, excluding 0.5 hour lunch, (7.5 hours) on English Working Days. Team Netsol's staff and offsite consultants are covered by its Professional Indemnity insurance policy.

7.2 Custom Statistical Reports

Buyers may request additional custom statistical reports based on the metrics already captured within BECS Statistics.

7.3 Post-Live Additional Training

7.4 Exit Fees
