The FPN issuance software enables CEOs to collate any incident-specific information (including photographs and electronic notes, fully integrated in real-time with the back-office allowing for automated FPN processing.

This maximises the efficiency and effectiveness of Enforcement Officers by removing the need to carry multiple devices or run multiple applications. An FPN can be instantly printed and issued to a non-compliant vehicle or individual.

Any captured data can automatically be used to create and send a postal-FPN. Data is automatically uploaded and synchronised with the back office in real-time, and for every FPN issued, each case file will be fully accessible by the council for audit and performance monitoring purposes.
