Annex 2 Services

Clause. 1 – Services part of the licences

1.1 The following activities are part of the licences as Included Services. Purchase of these services is either on a fair-use basis or limited by a specific number of purchases per year. The table below sets out the various activities within the Included Services:

LOGEX will provide advice regarding workarounds until they can be incorporated into the tool.

Clause. 2 – Ad-hoc services and Service Bundles

- 2.1 In addition to the Included Services described in Clause 1 and the technical support described in the Support agreements, LOGEX also offers the NHS Trust additional model-related services. Institutions themselves may decide whether or not to purchase these additional services. Such services are in principle an extension of the products subscribed for by institutions and are not necessary to use the products.
- 2.2 Because it can be difficult for institutions to make a good assessment of their own need for such services in advance, LOGEX will assist institutions in making this assessment.
- 2.3 The NHS Trust may decide to use additional services on demand (**Ad-hoc services**). LOGEX charges a fixed daily rate for these Ad-hoc services. The 2026 fixed daily rate is £,1640 excluding VAT, and will be indexed annually by 4% on the 1st of January. A discount does not apply to the purchase of such days.

- 2.4 The NHS Trust may also decide to purchase one of the **Service Bundles** defined in this Clause on an annual basis during the term of the Order Form. These Service Bundles contain a fixed number of hours of services to be provided during the calendar year. Institutions may decide for themselves what additional services they require, as long as the work requested is in line with the use of the Products subscribed for by institutions.
- 2.5 LOGEX offers five Service Bundles which differ in terms of the number of hours they contain. The smallest bundle ('XS') contains 40 hours of service (or 5 working days of 8 hours); the largest bundle contains 400 hours of service (or 50 working days of 8 hours). The 2026 undiscounted hourly rate is £204.90 excluding VAT; larger bundles have a higher discount percentage than smaller bundles. Rates are indexed by 4% on the 1st of January.
- 2.6 The Service Bundle is always purchased at the beginning of the calendar year. LOGEX informs the NHS Trust on a regular basis about the total number of hours already used, as well as the hours still available in the purchased Service Bundle. In addition, the NHS Trust can always contact LOGEX to gain an insight into the use the remaining number of hours. It is up to the NHS Trust itself to spread and deploy the hours within the Service Bundle over the year. Hours not used by the NHS Trust at the end of the calendar year expire.
- 2.7 If, during the calendar year, it appears that the purchased Service Bundle is not sufficient for the amount of services desired the NHS Trust may decide to purchase additional Ad-hoc services. In addition, it is also possible to purchase a larger bundle, once or for the remaining term of the relevant Order Form, with retroactive effect as of the 1st of January of that year. To do so, the NHS Trust must notify LOGEX in writing via email. It is not possible to switch to a smaller bundle than contractually agreed.
