1 G-CLOUD COMMERCIAL PRICING STRUCTURE

Rossera offers the following three pricing models. These can be offered standalone or combined to suit client requirements. All pricing is accompanied by a transparent breakdown of its composition.

Note: License and support packages available on request for Rossera's Process Automation suite of solutions aligned to Oracle Fusion and e-Business Suite.

1.1 Time and Materials

Time is billed 1 month in arrears based on resource utilised in line with SFIA rate card.

1.2 Fixed Price

Fixed price for a deliverable of fixed scope. Pricing is based on estimated resource in line with SFIA rate card with an amount of contingency built in depending on risk factors such as clarity of requirements and scope definition. This is typically 15% of planned SFIA costs.

1.3 Call Off

Purchase a number of days resource from SFIA rate card in advance for use over an agreed period of time such as 1 year.
