Pricing is an annual license based on the number of Council Tax Hereditaments within the Buyer's jurisdiction. All prices exclude VAT.

The price includes unlimited user licences / accounts. There is no restriction on the number of "seats" in use at any time concurrently or otherwise.

Free API Integrations (where available)

All available API's are provided without additional annual or setup charges. Our API's use OpenAPI (swagger) specifications and are available to any authorised user of the system.

Additional support for API integrations and training is available to be purchased through our G-Cloud service "Cloud Engineering and Support Services" if required.

Optional sub-tenant / licence sharing internally

Buyers may choose to "share" this service within their organisation, e.g. to other departments. For Credits based licences the credits are consumed by the Buyer organisation as they are used by sub tenants. There is no requirement to distribute and balance allocations of credits to subtenants.
