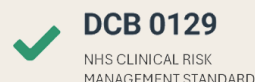

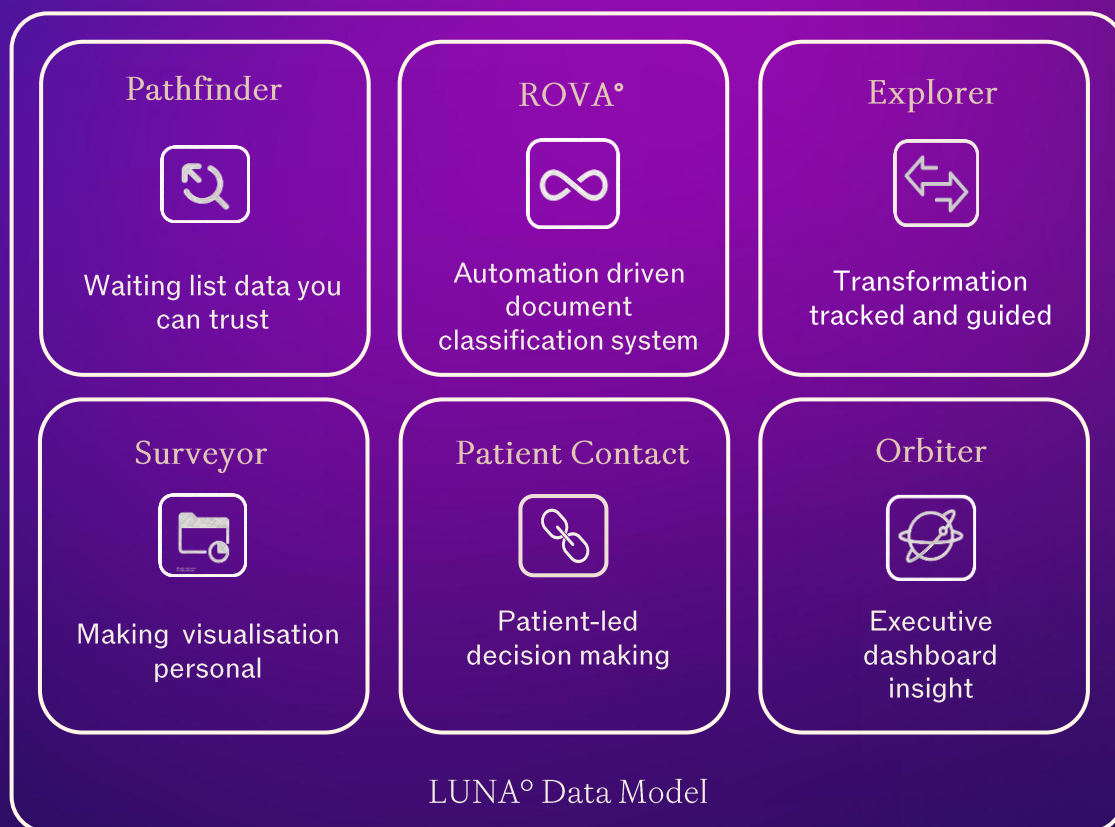

- Pathfinder – Gives a complete, validated view of all RTT and non-RTT pathways so teams can see the true waiting list position and identify required actions.
- ROVA° – Automatically reads clinical documents to find missing outcomes, discharges, and follow-up needs, greatly increasing validation speed and accuracy.
- Explorer – Provides interactive dashboards that show where delays, risks, and data issues occur, supporting clearer and faster operational decision-making.
- Surveyor – Presents personalised patient journey views using structured and unstructured data to show pathway history and clinical context.
- LUNA° Patient Contact – Supports efficient outreach to patients for validation and follow-up, reducing administrative workload and helping teams manage pathways safely.
- LUNA° Orbiter – Monitors data flows between systems and alerts teams to breaks or anomalies, maintaining stable reporting during routine operations and major changes such as EPR go-lives.

- Data Model – A standardised, high-quality data structure that combines information from multiple systems into one reliable source of truth.
- Data Cleansing – Automated and expert-led processes that remove errors and duplication and improve completeness across all pathway data.
- Elective Performance Improvement – Tools and insights that help teams improve flow, reduce backlogs, and manage capacity effectively using accurate, validated information.

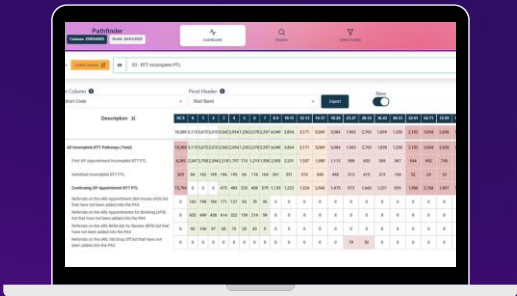

- Improves patient safety, as urgent patients can be identified and prioritised quickly and accurately.



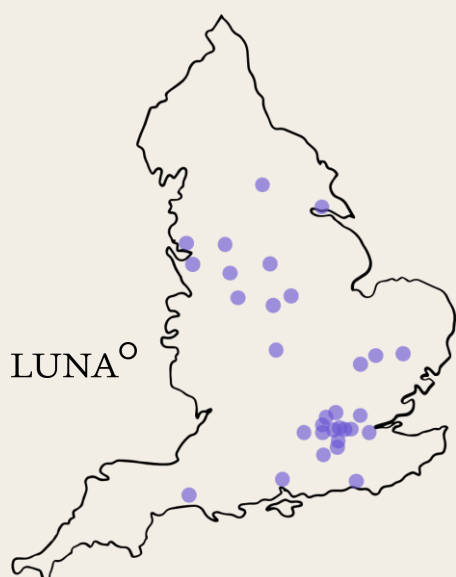
