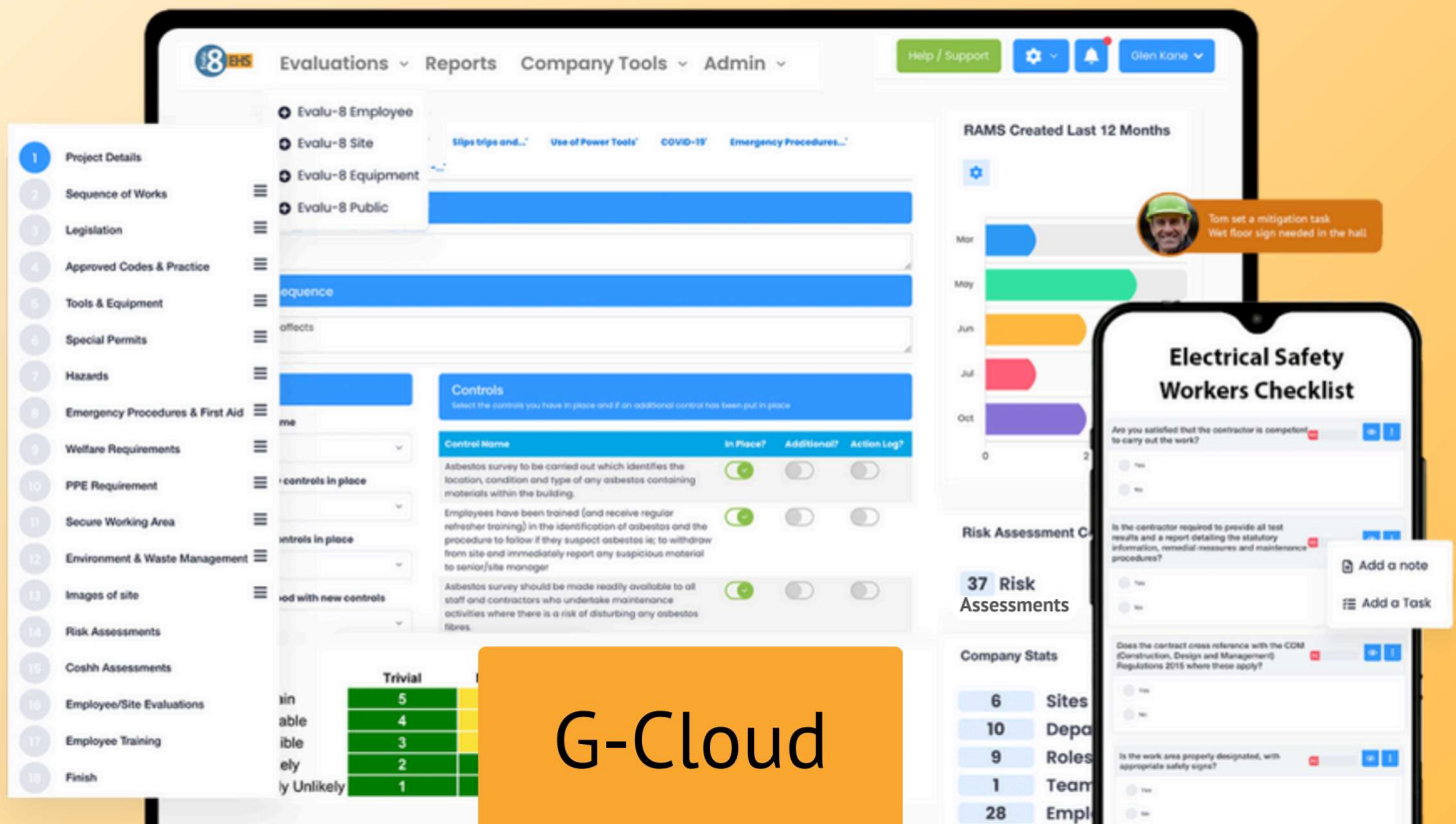

What are the charges?

Charges are made up of a Core EHS user license plus at least one additional module you select. Core EHS is £2.50 per license, per month, with a minimum of 10 licenses.

Modules are charged per organisation, per month. A one-off setup and onboarding fee applies, calculated as three times your first month's invoice. All prices are excluding VAT.

What are the support costs?

Support is included in your monthly costs. You can raise tickets via the online system, call our help desk, or use the online chat function.

Do you offer a charity discount?

Yes, there is a discount for any registered charity.

What is the minimum contract length?

We provide a minimum of 12 months contract of service.

What do you charge for upgrades and new features?

We do not charge extra for upgrades to the modules you already subscribe to. These updates are delivered as part of your monthly fee. Any new modules or additional functionality beyond your existing subscription are priced separately and only added with your approval.

What is your cancellation policy?

We ask for three months' notice from a customer prior to the end of the contract term.

What are the costs associated with extracting my data?

There is no charge for extracting data. Data can be extracted via CSV
