Pricing where estimated counterparty number exceeds 150,000:

The above pricing bands cover the scoring of up to 150 000 counterparties per annum.

For clients with more than 150,000 counterparties requiring scoring, the annual fee will be adjusted by a proportional multiplier equal to the ratio of the client's actual number of counterparties to the billable cap (150,000). The adjusted fee is calculated as follows (using Single Team pricing as an example):

$$\text{Adjusted Annual Fee} = £94,230 \times (\text{Actual Counterparties} / 150,000)$$

The resulting amount will be rounded to the nearest £100 (consistent with the rounding convention used for the GBP column).

Example:

200,000 estimated counterparties requiring scoring, single team licence: $£94,230 \times (200,000/150,000) = £125,600$ Adjusted annual fee
