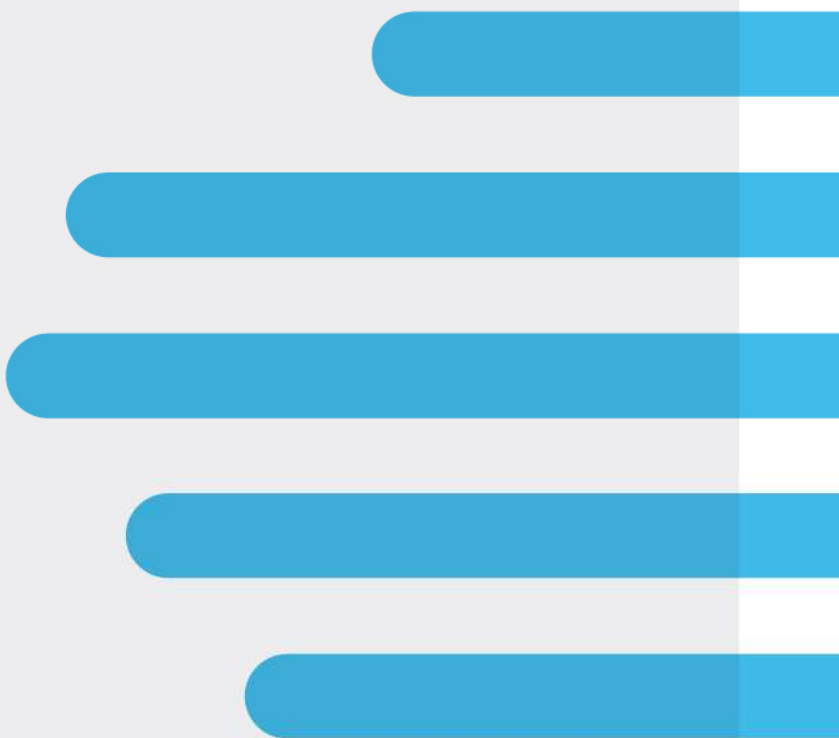

PRICING

The following yearly subscription price is exemplary for a standard IQVIA Trial Manager Project, and it is inclusive of the Core modules as well as the optional modules and interfaces more regularly required (Reporting/Dashboarding, XML-interface and HL7 Listener).

Several additional modules and products have not been included but can always be added to the basic configuration considered in the subscription. These tools include Biobank, Workflow Engine, Study Register, Patient App, Raw Data Archive, Meta Data Repository, additional interface technologies, or device integration.

The subscription considers a scaling of price, linked to the number of users of the solution. The basic 'Entry-level' option is set at 10 users, and blocks of 5 users can be added without limit. The subscription price per each 5 users decreases its price at 100 users. Each tier is independent, and its price applies independently from the total number of users subscribed.

The subscription does not consider the implementation services required to set up the solution. Those are valued separately and are dependent on the complexity of the project. Complexity is to be assessed on a case-by-case basis and will be linked to (e.g.) the data sources and systems to integrate, the reports to generate, etc.

Implementation Services range, linked to the scope of the subscription, and valued as a one-time fee, independent from the subscription value:

Detailed modules considered in the Subscription:

Name	Description
System-Module (Core)	Basic module with secure login for using IQVIA HDRP Core and the creation of patients, episodes, diagnoses, and measurement findings, including an advanced search interface using Elastic Search technology.
System-Module (Report Engine) Named User License	Named User License for the use of Reporting functionalities. Includes (in extracts): - Possibility to upload executable reports, for database queries and computations according to specifications (e.g., study enrollment performance)
System-Module (Dashboard) Named User License	Named User License for the use of the dashboard functionalities. Includes (in extracts): - Real time view on data in IQVIA HDRP (includes standard widgets, and potentially customised widgets)
System-Module (IQVIA Trial Manager) Named User License	Named User License for the use of IQVIA Trial Manager functionalities. Includes (in extracts): • Study Register with Patient-Trial Matching • CTMS with eCRF designer and EDC functionality • Data export, SAE tracking, Budget management
Interface (XML-Import/-Export)	Named User License for XML/REST API (can be used for legacy data imports, or custom data exchange jobs)
Interface (HL7-Listener)	Interface License for HL7 Listener (can be used for ingestion of source data from systems that can provide access to HL7 standard version 2.2-2.6 [for example Hospital Information System]. Pricing is for 4 message types [most commonly: ADT, ORU, BAR, MDM] and ingestion of data from one system).

Key Assumptions:

- SaaS model Subscription License for IQVIA Trial Manager is priced based on number of users.
- Subscription yearly price includes the modules identified above.
- Annual IQVIA Trial Manager Maintenance & Support is included within the Subscription price.

- d. Software Maintenance Service, and the provision of fixes and updates is under its continuous coverage over the term of the contract, and the Licensor (IQVIA) has received due payment.
- e. At time of delivery, latest available version of IQVIA Trial Manager will be delivered.
- f. The Implementation Services required to set up a full operational solution will have to be evaluated on a case-by-case basis, and its cost added to the subscription as a one-time fee.
- g. Integration or data exchange with systems and devices that are not capable to send HL7, FHIR or XML, or out of service, or out of support contract are excluded, and should be assessed on a case-by-case basis.
- h. Integration to Third-party systems includes the related analysis and software development to connect from IQVIA side to the intermediary integration engine/ platform, any activities to be done at the third-party system side is the responsibility of Client or the respective third-party vendor.
