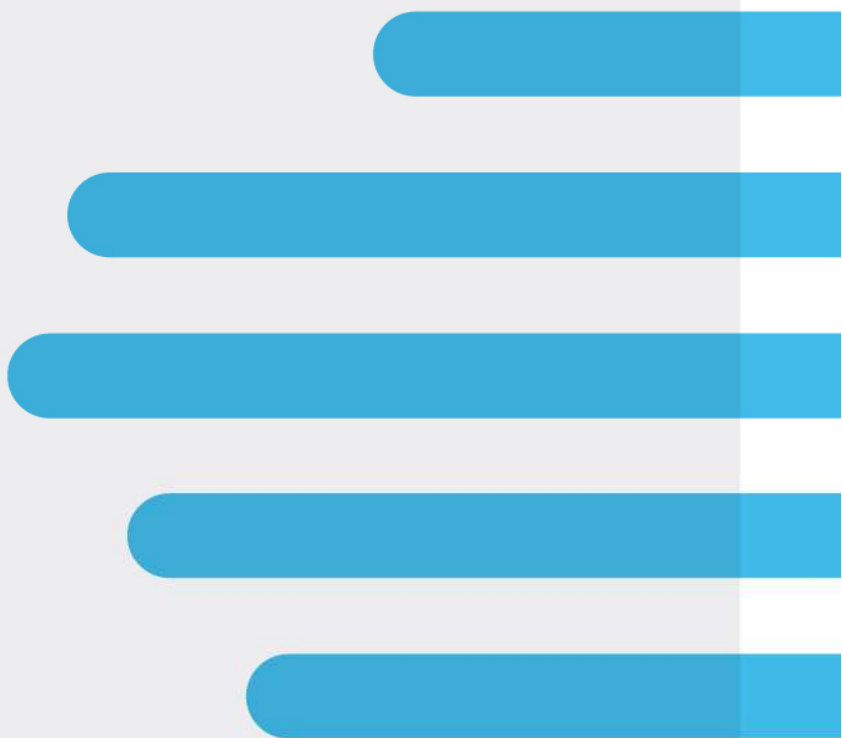

Care Pathway Analytics (CPA) is a service, which enables healthcare organisations to view and understand longitudinal patient pathways.
