Pricing overview

B-SAFE is a modular software. This means each B-SAFE module can work as a standalone module but can be seamlessly integrated with others to provide organisations with one system for solving common enterprise, Governance, Risk and Compliance Challenges.

Price depends on the number of users/licenses and the number of modules you select.

For complex governance and risk management, we recommend to select at least the following:

- Corporate risk assessments (with causes, consequences, controls, appetite levels, etc.)
- Mitigating Actions
- Quantitative analysis
- Matrices and Appetite levels (for multiple matrices support)
- Risk indicators
- Issues

Examples of project price calculation

Example 1.

You have 10 managers that need access to the systems.

You need Corporate risk assessments and Mitigating Actions schemes modules.

You need just standard support in working hours.

You will upload data from your previous systems via csv using built-in import functionality yourself. And you will export data at the end of the contract yourself using built-in export functionality.

You will manage all users accounts in the system (no integration with HR). You need just email and push notifications.

You select a 2-years term for the contract and pay in advance for 2 years.

So the pricing schedule will be the following:

So you get the system for 2 years with all you need for just 6,290 GBP.

Example 2.

You have 500 managers that need access to the systems.

Your managers often work offsite, so they would prefer mobile applications.

You need Corporate risk assessments, Quantitative analysis, Matrices and Mitigating Actions modules.

You need just standard support in working hours.

At the contract start you need to transfer your Corporate risk assessments and Mitigating Actions from the previous solution and at the contract end you will need the assisted full data extract.

You will manage all users accounts in the system (no integration with HR). You need just email and push notifications.

You select a 5-years term for the contract.

So the pricing schedule will be the following:

So you get the system for a large organisation with all you need for 5 years for just 93,240 GBP.

Example 3.

You have 35,000 users. 5000 need normal access to the system and 30000 need read-only access.

Your managers often work offsite, so they would prefer mobile applications.

You need Corporate risk assessments, Mitigating Actions, Quantitative analysis, Matrices and Appetite levels, Risk indicators, Issues, Vocabulary, Projects and Programs, Documents management modules.

At the contract start you need to transfer your Risk assessments, Risk indicators, Issues and Projects from the previous solution and at the contract end you will need the assisted full data extract.

You will manage users accounts in your HR system (so integration with HR is required).
