Interpretation

Capitalised words have defined meanings under the following conditions. These definitions apply regardless of singular or plural usage.

Definitions

Application: the software provided by the Company, named Byte.

Application Store: the platform where the Application is downloaded, such as the Apple App Store or Google Play Store.

Affiliate: an entity controlling, controlled by, or under common control with the Company.

Account: a unique account created by You to access our Service.

Country: United Kingdom

Device: any device capable of accessing the Service.

Feedback: suggestions or input submitted by You.

Goods: items offered through the Service.
