- Bands are determined by the maximum number of named buyer users during the contract term.
- Each band includes an annual allowance of referrals and a document storage pool.

Definitions

Named Buyer User: A user account belonging to the contracting authority tenant (e.g., case officers, approvers, auditors).

Referrals: One client referral from initiation to closure.

Document Storage Pool: Total storage used by buyer-authored documents generated from templates or uploaded within Proquro under the contracting authority tenant.
