

Parkable UK Limited - Terms and Conditions

1. Agreement to Terms

These Terms and Conditions constitute a legally binding agreement made between you, whether personally or on behalf of an entity ("you") and Parkable UK Limited ("we", "us", or "our"), concerning your access to and use of the Parkable platform.

2. Intellectual Property Rights

4. User Registration
