

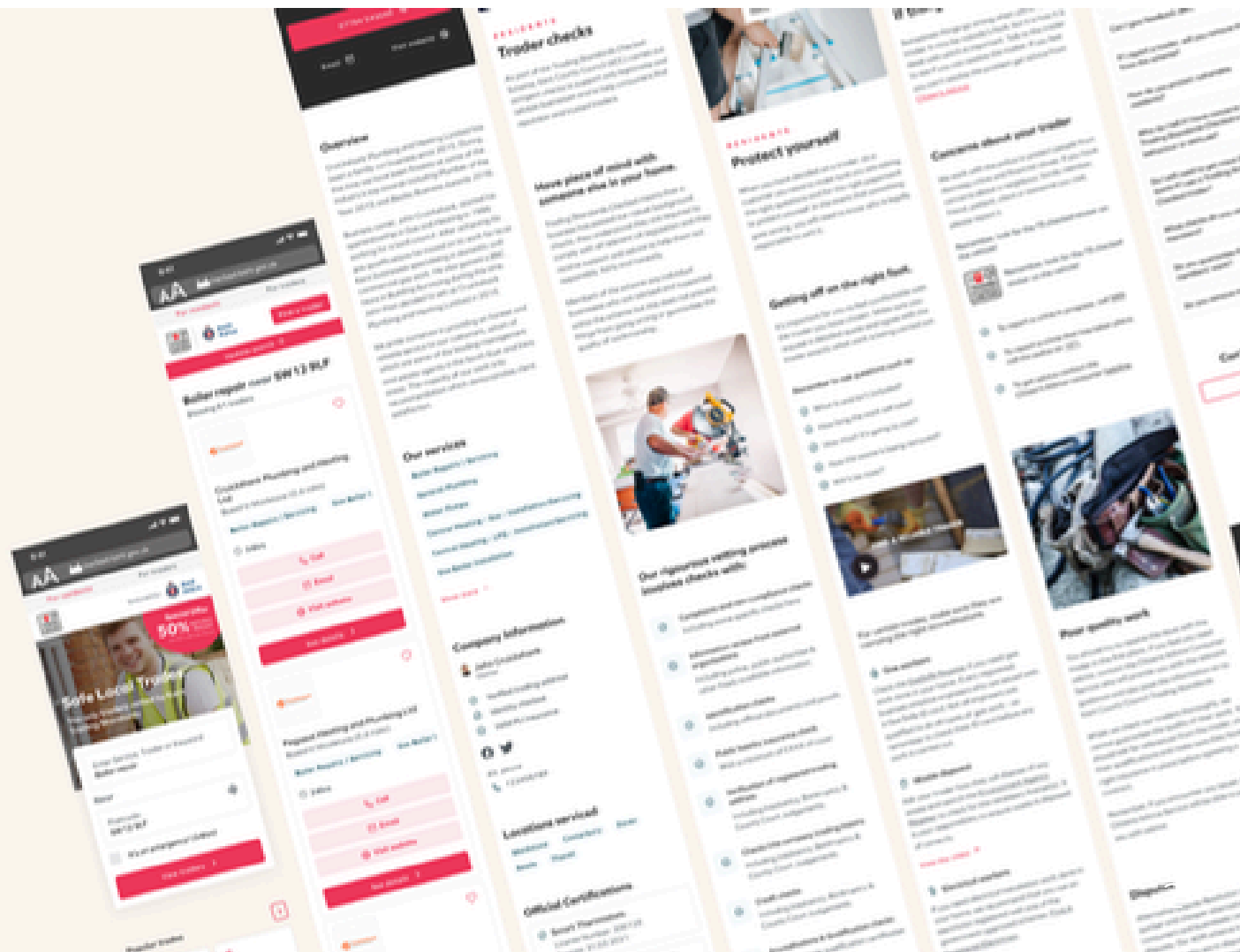

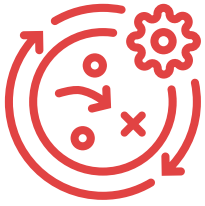

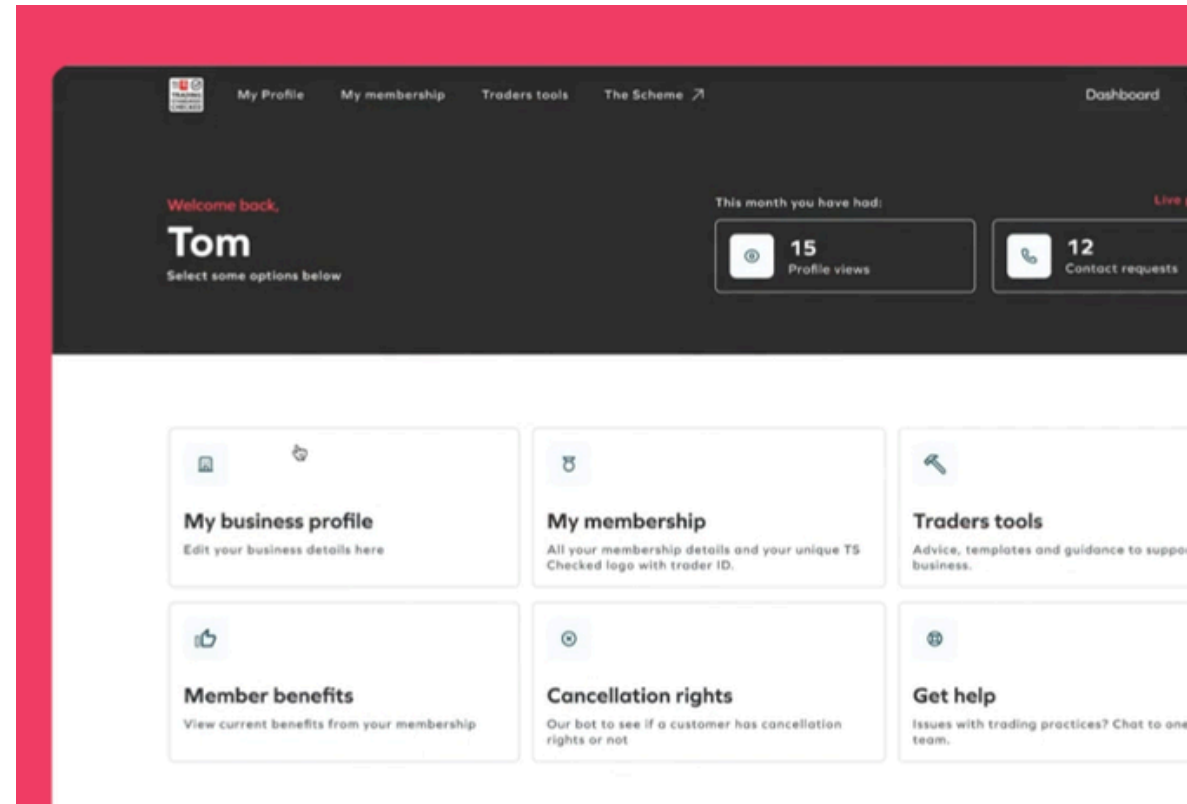

Are aspects configurable?

How are member payments taken?

We integrate with your chosen payment gateway (typically Stripe or GovPay) to take member subscriptions and handle renewals. Emails and notifications are all automated and built in to save you time.

Is all data held in the UK?
