3 Generative AI Solutions - an overview

Generative AI Solutions provides fully managed, cloud-based services that enable organisations to specify, deploy, and scale AI-driven automations through a secure, intuitive web experience. We develop and manage reusable automations (e.g., for summarising evidence, drafting reports, or producing structured notes and actions) to drive consistency across departments and directorates for our clients. Where required, we include full Human In The Loop (HITL) control to ensure professional judgment, quality assurance, and governance throughout.

The service supports a wide range of input types, including Word, PDF, and scanned documents and bot access to online meetings, with audit trails and citation features that trace generated content back to source, reinforcing transparency and evidential rigour. Open standards and APIs enable interoperability with existing systems and processes.

Security and compliance are embedded by design: data is processed and stored within the UK/EU/EEA, encrypted in transit and at rest, and protected by Single Sign-On (SSO), Multi-Factor Authentication (MFA), and Role-Based Access Controls (RBAC).

4 Service Description

Agilisys provides AI Consultancy & Development services that take organisations from strategy and policy, through use-case discovery and business case, into secure solution architecture, build, and run.

Our approach is modular: we blend advisory services (governance, operating model, policy), solution design (reference architectures, patterns, data readiness), and delivery (prototypes, pilots, and production implementations), including our own managed Generative AI SaaS components where appropriate.

All work is underpinned by UK-hosted security controls (SSO, MFA, RBAC, encryption) and HITL governance to ensure quality, transparency, and evidential integrity.

- **AI Strategy & Policy.** Enterprise AI policy, risk/ethics guardrails, DPIAs, responsible AI controls, alignment to NCSC Cloud Security Principles and ISO 27001.

- **Solution & Data Architecture.** Reference architectures for LLM-backed apps, retrieval-augmented generation (RAG), guardrails, vector search, prompt/template libraries, and secure tenancy design. Providing HLDs/LLDs, AI security model and integration patterns.
- **Model & Prompt Engineering.** Model selection (open/commercial), evaluation against public-sector tasks, prompt design and safety testing, few-shot exemplars, and template standardisation for consistent outputs.
- **Build, Test & Pilot.** Rapid prototyping and controlled pilots for summarisation, report drafting, redaction assistance, correspondence generation, and meeting notes/actions, graduating to production services with HITL checkpoints.
- **Integration & Automation.** Open-standards APIs and workflow orchestration to connect line-of-business systems (case management, EDRM, EPR), identity, and audit repositories; event-driven automation.
- **MLOps/LLMOps & Run.** CI/CD for prompts/workflows, model registry, monitoring (quality, bias, drift, latency, cost), feedback loops, and safe rollback.
- **Adoption, Training & Change.** Role-based training (practitioner, reviewer, admin), playbooks, comms, and enablement; establishing communities of practice and measurable adoption.
- **Security Controls.** Authentication, authorisation, and integration with line of business systems

4.2 Typical solution archetypes include, but are not limited to:

- **Digital Front Doors.** Citizen-oriented digital front doors for government digital services as a platform.
- **Document and evidence handling:** ingest, structure, and summarise multi-source evidence; generate consistent drafts aligned to local templates and practice; maintain citations to original sources for auditability.
- **Report and assessment drafting:** accelerate production of statutory reports and assessments with editable outputs and HITL oversight; standardise content while preserving professional judgment.
- **Information Discovery:** Orchestrates targeted searches across email, documents, case files, and shared repositories; applies relevance scoring to surface matches; maintains an evidence register for transparency. Guidance on SAR scope and stakeholder roles informs the end-to-end process.
- **Redaction Support:** Assists practitioners with redaction decisions and exemption tagging; records the rationale and links redactions to the appropriate policy references for FOI and UK GDPR.
- **Correspondence & templates:** Configurable templates (acknowledgement, clarification, disclosure, refusal/partial disclosure) and a secure delivery workflow aligned to local procedures.
- **Meeting capture and actions:** capture online discussions, produce structured notes, and extract action items to improve follow-up and accountability (available where organisations choose to enable meeting capture).
