HEALTH INFORMATICS CLOUD

Health Informatics Cloud (HIC) is a secure, UK health-focused cloud data platform with modular applications that help NHS providers and health boards turn raw data into operational and financial insight. It accelerates analytics delivery, supports privacy-preserving data sharing, and reduces time to value, helping organisations improve operational performance, financial sustainability, and transparent, auditable reporting. HIC also supports Provider Collaboratives by enabling governed pathway analytics and cross-organisation insight, and it can interoperate with Federated Data Platform (FDP) products to maintain coherent analytics across platforms through standards-based integration and shared semantic models.

HIC includes a managed cloud data platform foundation with healthcare-oriented data structures, standard ingestion patterns and connectors for common NHS data sources, and governed access controls aligned to organisational roles. It provides reusable semantic models and reporting accelerators for common BI tools, plus optional modular applications such as costing analytics and maternity insights. The service also includes documentation and onboarding support for tenant connection, identity integration, module enablement, and knowledge transfer, alongside security controls such as encryption in transit and at rest and role-based access to support NHS information governance expectations.

The annual subscription is for a production environment and includes the core HIC data platform and tooling, selected applications, underlying compute and storage (estimated based on customer volumes), ongoing support and ongoing maintenance updates and product upgrades.
