- Efforts to improve the speed, productivity and quality of the development lifecycle

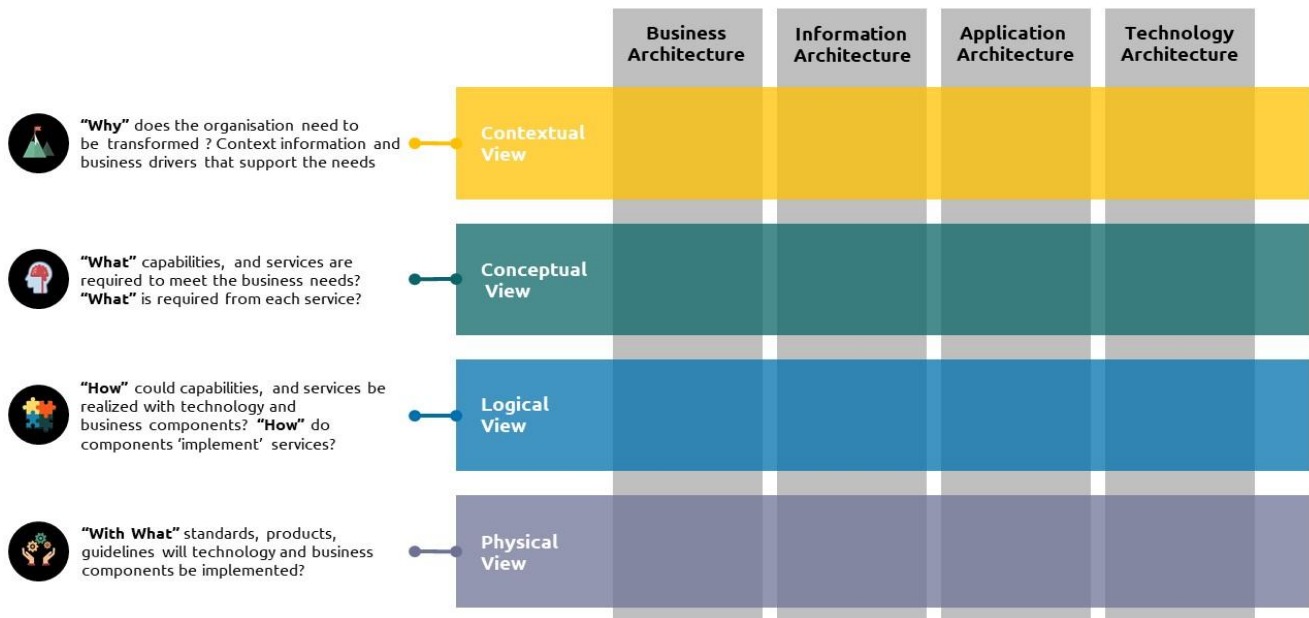
3 Our Approach

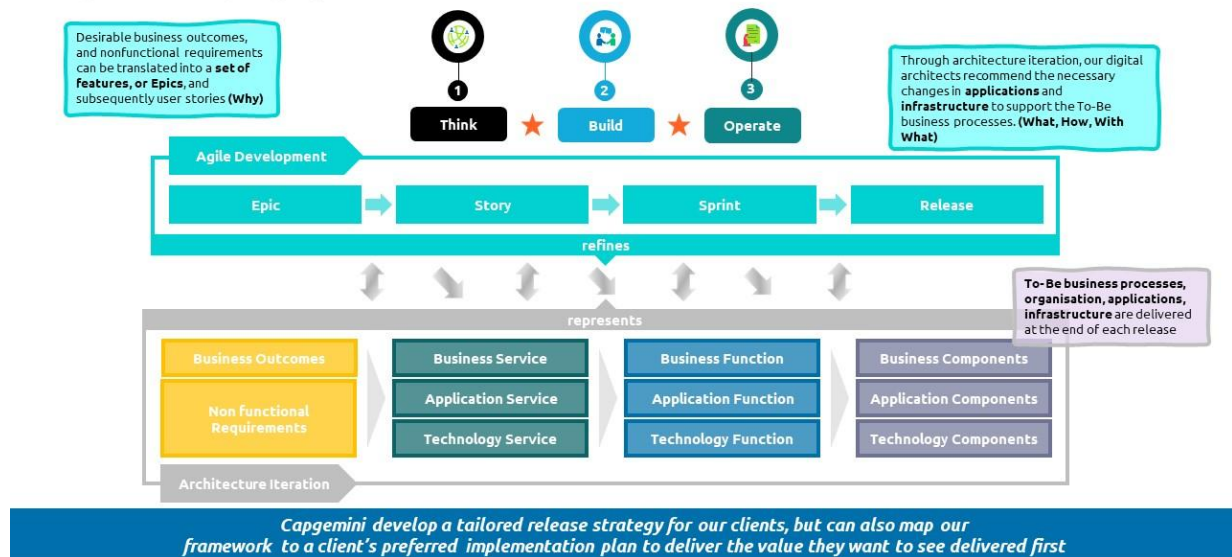
