### Service overview

The *AI Health Integration* service complements the FlyingBinary *AI Health Analysis* service, providing planning, data design, integration, validation and ongoing support capabilities.

The *AI Health Analysis* service leverages deep learning and custom AI models to deliver advanced patient care within a primary or secondary care clinical context across healthcare pathways.

Research has shown that societal health problems are a growing epidemic, placing incredible strain on our healthcare service providers. At the same time, the causes and impacts exhibit huge diversity, requiring high-touch, personalised care that is out of reach of classic clinical pathways.

The *AI Health Analysis* service can ingest frontline data from a variety of primary and secondary care clinical services, and then use custom AI models that specifically understand both the pathway and the data context to deliver personalised clinical management recommendations. The service is advisory only, the clinician remains responsible at all times for specific applications for individual patient pathways.

The *AI Health Analysis* service can include any mix or all of the following components:

- Planning and design
- Data migration and integration
- Pathway profile customisation
- AI model output validation
- User training
- Ongoing support

## **Planning and design**

The integration of an advanced AI service into an existing clinical setting requires specialist planning, risk assessment and experienced project management.

## **Data migration and integration**

The *AI Health Analysis* service requires key data from existing frontline services. The required data must be carefully analysed and screened, and transformed into schemas that are efficiently consumable by the AI models. At the same time, personal information must be effectively secured and controlled.

## **Pathway profile customisation**

Health pathway profile customisation for AI models is an emerging skill, requiring expert guidance and assistance to ensure the resulting profile runs effectively and generates good quality output recommendations.

## **AI model output validation**

It is vital that all AI model use is evaluated by expert resources to ensure output quality and overall utility within the clinical setting. This requires advanced knowledge of AI test and validation techniques, as well as selection and curation of test data sets by experienced resources.

## **User training**

It is important that all users of AI systems understand and can recognise the benefits and limitations of these technologies. AI-enabled services operate in some fundamentally different ways from classical compute services and require a clear understanding of these differences and the outcomes they generate in order to use them effectively, fairly and without bias.

## **Ongoing support**

The *AI Health Analysis* service includes basic ticket support for queries and incidents, but especially at the beginning, it is highly recommended that the additional hypercare service which is available to provide faster and more integrated support.

# Pricing

The *AI Health Integration* service is priced on a day rate basis. The day rates are provided in the FlyingBinary Pricing Rate Card below. These rates start at £500 per day and increase to reflect the scale and complexity of the source and destination requirements of the service required.
