1.4 Unit Based Pricing

This document provides some example sizes of IBM Cloud DaaS

Pricing is done in terms of Flex Credit, the number Flex Credits required is determined by the desktop configuration.

Monthly - 1 Year Term, Monthly - 1 Year Term

Customer commits to a purchase a minimum monthly quantity of Cloud PC products in the form of Flex Credits, under a 1 year term.

£0.82 GBP/Dizzion Flex Credit (1 Credit), Selected Plan

Monthly - No Term, Monthly - No Term

Customer commits to a purchase a minimum monthly quantity of Cloud PC products in the form of Flex Credits, on a month-to-month basis.

£0.88 GBP/Dizzion Flex Credit (1 Credit)

Prepaid - 1 Year Term, Prepaid - 1 Year Term

Customer commits to purchase a minimum annual quantity of Cloud PC products in the form of Flex Credits, under a 1-year term.

£0.75 GBP/Dizzion Flex Credit (1 Credit)

Minimum of 25 Desktops for Cloud PC Core, and 50 Desktops for Cloud PC

Complete for all options.

1.5 Sector Pricing

Available subject to sizing and Statement of Work.

1.6 Resourced Based Pricing

Separate pricing will be available for operational resource, depending upon requirements.

IBM will convert the U.S. Dollars charges using an exchange rate as required by law or based upon a Bloomberg daily spot rate on the business day prior to the date IBM prepares your bill in your local currency.
