Service Definition overview

CGI talked to 150 C-suite executives from the UK's largest organisations across banking, insurance, telecoms, retail and utilities. From this, we discovered that:

Table-top exercises - what are they?

Table-top exercises are "around the table" discussion based one-off events lead by CGI facilitators, allowing you to play out various security scenarios, e.g. a ransomware attack, in order to develop appropriate plans in the event of such an attack. Some of the principles and goals of table-top exercises are shown opposite.

They are based on the National Cyber Security Centre's (NCSC) "Exercise in a Box", with additional CGI Cyber expertise. They:

- Take between 1 to 3 hours (exercise dependant).
- Can be run virtually or physically.
- Provide a full report at the end detailing discussion points.

Why you need to take action

Understanding why cyber-attacks happen and building resilience to them can be complex and extremely challenging without the right expertise or knowledge, but it is absolutely vital for security. Increasingly organisations are finding they need external support in order to deal with attacks and prevent them from happening again. CGI's table-top exercises will enable you to:

- Understand your organisation's preparedness and resilience to cyber attacks.
- Practise your response to critical cyber incidents in a safe environment.
- Ensure that key personnel are aware of their roles and responsibilities.
- Ensure that policies and procedures are up-to-date and effective.
- Help identify and improve ways of managing cyber security threats.

- Supply Chain Software
- Managing a Vulnerability Disclosure.
- Home and Remote Working
- Supply Chain.

- Mobile phone theft and response.
- A ransomware attack delivered by a phishing email.
