Overview

ReStart provides flexible pricing models to support both Capital and Revenue funding approaches and to align with the budgetary and operational requirements of individual public sector organisations.

The pricing information supplied under this G-Cloud 15 framework is indicative only and is provided to support high-level commercial comparison between suppliers. It does not constitute a binding offer or full statement of costs.

Final pricing will be confirmed following call-off contract award and completion of detailed service scoping and technical discovery, at which point ReStart will issue a formal quotation tailored to the Authority's specific requirements.

IMX Archive / IMX Platform – Indicative Pricing Structure

Pricing for the IMX Archive service is based on the following cost components. The example values below are provided for illustration purposes only and are subject to change based on the Authority's final requirements.

Assumptions used for this indicative example:

- Up to 10 Systems
- 1TB of archived data hosted within the ReStart Cloud
- Standard implementation and configuration complexity
- Standard G-Cloud support service levels
- No complex data migration, bespoke development, or specialist integration services included
- Contract term to be agreed at call-off

Where any of these assumptions differ, pricing will be adjusted accordingly.

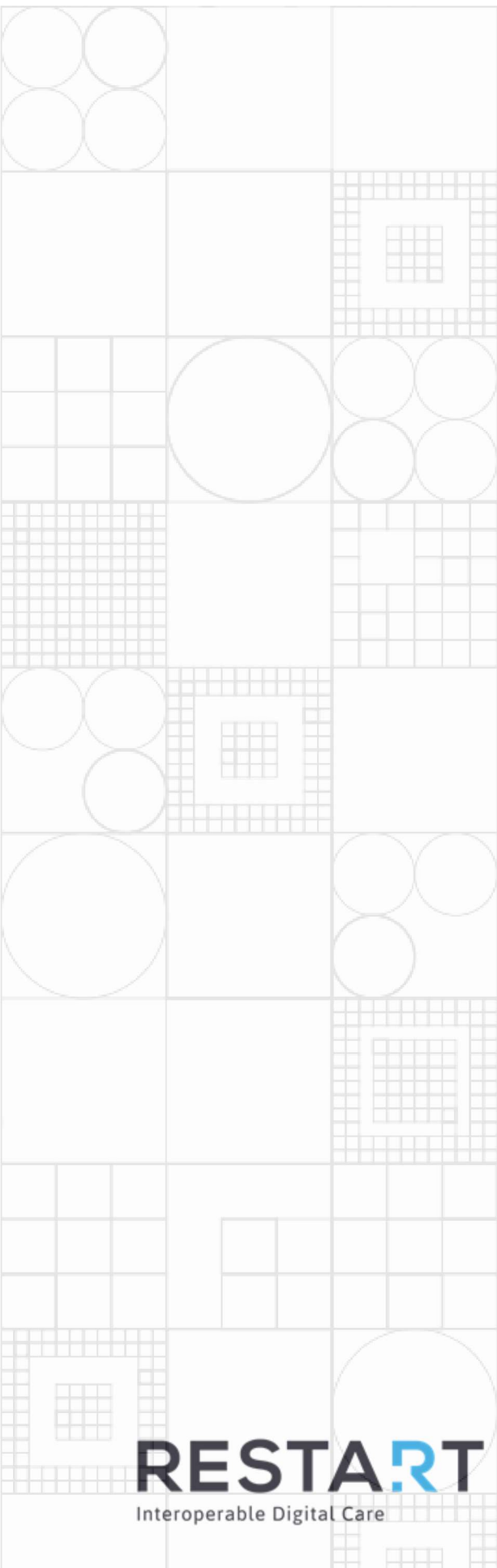
