It uses Lifelight.ai amongst others for accurate remote patient assessment, streamlining data capture via user-friendly forms and secure integration into clinical records. It offers clinicians real-time data for proactive health management, improving patient outcomes, and optimising workflow. It supports integrated or standalone multi-cloud deployment and is applicable across Health, Social Care, Private and Third Sector operations

By providing a comprehensive, secure platform for remote patient assessment and real-time data analysis, AireVitals empowers organisations to deliver more efficient and proactive health management.

Implementation

Managing change and requirements

The implementation process begins with initial workshops to support the analysis of user and patient recording deployment requirements and the clinical transformation the platform will bring. We work collaboratively to configure the platform to local needs, ensuring effective knowledge transfer so the local team can manage ongoing maintenance.

Development of solutions

We work with the local team to configure the platform to local needs, ensuring effective knowledge transfer during this process so the local team can manage ongoing maintenance effectively. We then provide testing support and guidance ready for release into the production environment.

Training

We provide on-site and online training as required for local staff to be able to manage new requirements or as refresher training if required.

The aim of the training is to ensure that where a customer requires training in any of these items they understand how the solution can be utilised to meet their workflow and pathway requirements.

Hosting and technical requirements

AireVitals supports multi-cloud deployment, including **Public cloud, Private cloud, and Hybrid cloud**. It uses segregated resources (docker containers) and supports connection via **HSCN, Private network or public sector network, TLS (version 1.2 or above), or IPsec or TLS VPN gateway**. The platform is accessible via **Modern browsers e.g. Edge, Chrome, Firefox, Safari**. There are **no constraints in running the service**. Blood Pressure readings can only be taken via a mobile app.

APIs and Configuration

- **APIs:** There are a number of APIs across our platform, which allow you to programmatically access functionality within each service. The APIs are secure by design, and follow RESTful principles. There are also GraphQL APIs which allow you to fetch discrete data points using selective querying. APIs can be used to access available forms, query data collected through forms, retrieve lists of workflow tasks and create new patient records. It is not possible to delete patient data through the APIs, you are able to withdraw information, but it cannot be permanently delete for audit purposes.
- **API Documentation:** Made available dynamically through **Open API (also known as Swagger)** and **HTML** product specific documentation sites.



- **Self-Administration:** Authorised users can self-administer the configuration settings for their organisation and their local integration needs.
- **Accessibility:** WCAG 2.2 AA compliant. We have used both online and offline accessibility testing tools and have installed local accessibility tools on developer workstations.

Support
