Assumptions

iTrent Software Assumptions

1. Our pricing is submitted under the terms of a rental agreement through a low initial one-off payment, together with an annual fee covering the rental, software support and maintenance, service desk, new releases (including statutory releases) and provision of account management.
2. All prices exclude VAT.
3. The initial fee is due on contract signature with annual fee invoiced quarterly in advance from contract signature. Implementation costs are invoiced on a monthly basis.
4. iTrent is licensed on the number of employees under management not on the number of users or number of payrolls being processed.
5. Any increase in employee numbers will attract additional initial and annual fees.
6. Licensing is based on a fixed term rental model and not in perpetuity.
7. Maintenance will be charged at a rate of 20% of the total software costs.
8. Additional modules can only be used in conjunction with one of the base modules.
9. Any module purchased during the term of the contract will attract additional initial and annual fees.
10. Hosting costs are included in the iTrent software costs. These are estimated, based on the use of multi-tenanted servers and subject to a full architectural design, scoping and agreed SLA.
11. Hosting costs include 3 environments per Contracting Authority Production, Live/Test/Development plus disaster recovery.
12. Connectivity to the client is based on secure internet access only and does not include any fixed line costs which can be provided subject to scoping.

Payroll Processing Assumptions

1. All prices exclude VAT.
2. The annual fee invoiced quarterly in advance from contract signature.
3. The indicative processing costs are based on 1 monthly payroll. Additional payrolls/frequency will require scoping and costs agreed.
4. The agreed processing options and responsibilities will be documented in the Service Level Agreement, which will be presented as part of the contract.
5. The implementation assumes that you will provide us with all requested data from your existing supplier to enable us to load into the system.
6. Postage or courier costs are additional and will be charged at cost.

3. Pension Schemes listed are equivalences based on effort to produce – MHR can advise on the effort for schemes not listed and the appropriate fit to the above.
4. Quotes are for a single scheme but includes other associated outputs e.g., starters / leavers / changes
5. Assumes hosted with MHR – costs to be discussed where MHR does not host the candidate HCM
6. Data quality will be the direct responsibility of the customer. MHR accepts no liability where the failure of a service is due to the actions or inactions of the customer or the failure of the customer to meet its obligations as set out in the Service Level Agreement (SLA).
7. Prices do not include professional services for set up, this will be determined (as appropriate) based on further discussion.
8. Moving forwards, any subsequent changes to the underlying spec from the individual Fund for the scheme(s) in question will be reviewed and agreed as to the effort required to amend. Change control will be exercised, and any resultant charges discussed as appropriate.
9. The PDS infrastructure has been based on previous experience but will be reviewed periodically to ensure it remains optimised for performance. If additional resources are required for the infrastructure this will be discussed accordingly to agree costs.

10. Pensions Admin Service – as a pre-requisite, if taken, PDS must be in scope to automate the outputs for the scheme(s) at the prevailing cost. 5. The core “MHR LMS” price quoted includes productised iTrent / People first integration where a customer has / or purchases either HCM platform from MHR
6. Overage will apply if agreed concurrency is exceeded for a given month. Prices available upon request.
7. Licence costs quoted will include a first year initial and recurring annual from year 2 onwards where indicated as “per annum”
8. Indicative costs quoted for “typical LMS rollout” based on a set scope for our proven Assisted Build approach and includes access to the “University” to allow self-learning as part of implementation.
