Cloud Software – Forensics Cloud Software Rate Card

This Rate Card applies to the following services:

- PwC eDiscovery Software - Relativity: Search, Review and Disclosure Services
- PwC Contract Discovery and Analytics Platform Services

The rate card below sets out the applicable costs required to deliver the services named above, aligned to the requirements of the buying organisation. In provisioning the eDiscovery cloud software, in addition to technology costs, professional service fees will be incurred for activities such as to load data into the service. In most circumstances, prior to this work commencing, a provider will have already performed data collection and processing tasks (as described in the Specialist Cloud Services – PwC eDiscovery Cloud Services service description).

The process of provisioning the software, loading documents onto the service and setting up a simple workflow takes anywhere between one and three days, depending on the complexity of the scenario a client needs support with. Ongoing support of the platform will be provided as and when needed by our team of eDiscovery specialists.

This document provides the day rate card and pricing approach applicable to all of the above services. A range of rates is provided to reflect the breadth of roles and experience levels available to deliver the services, ensuring that the skills and seniority of resources deployed are appropriately matched to the business needs of the buying organisation.

PwC Rate Card Assumptions

1. Supplier Staff will work an eight-hour day exclusive of travel & lunch.
2. Supplier Staff will work a five-day week, Monday to Friday excluding National Holidays
3. Travel costs within the M25 are included in the day rate. Travel outside of the M25 will be billable to the customer department at an agreed standard rate which may be set out in the Call Off Contract or otherwise agreed between the Parties.
4. For data hosting, the volume of data being hosted is calculated using the storage space consumed by the information held within any native or image files associated with the data, where each document must require a native.
5. Contracts Data Extraction, Data Breach and Processing do not need to be applied to all documents that are loaded and hosted by the service, only those where data needs to be analysed and extracted via the specialist applications.
6. If required we can provide a Private Cloud instance for specific security requirements, pricing is based on commitment of user licences and number of instances.
7. The Supplier is willing to discuss client-specific requirements which may result in bespoke pricing arrangements.
8.
