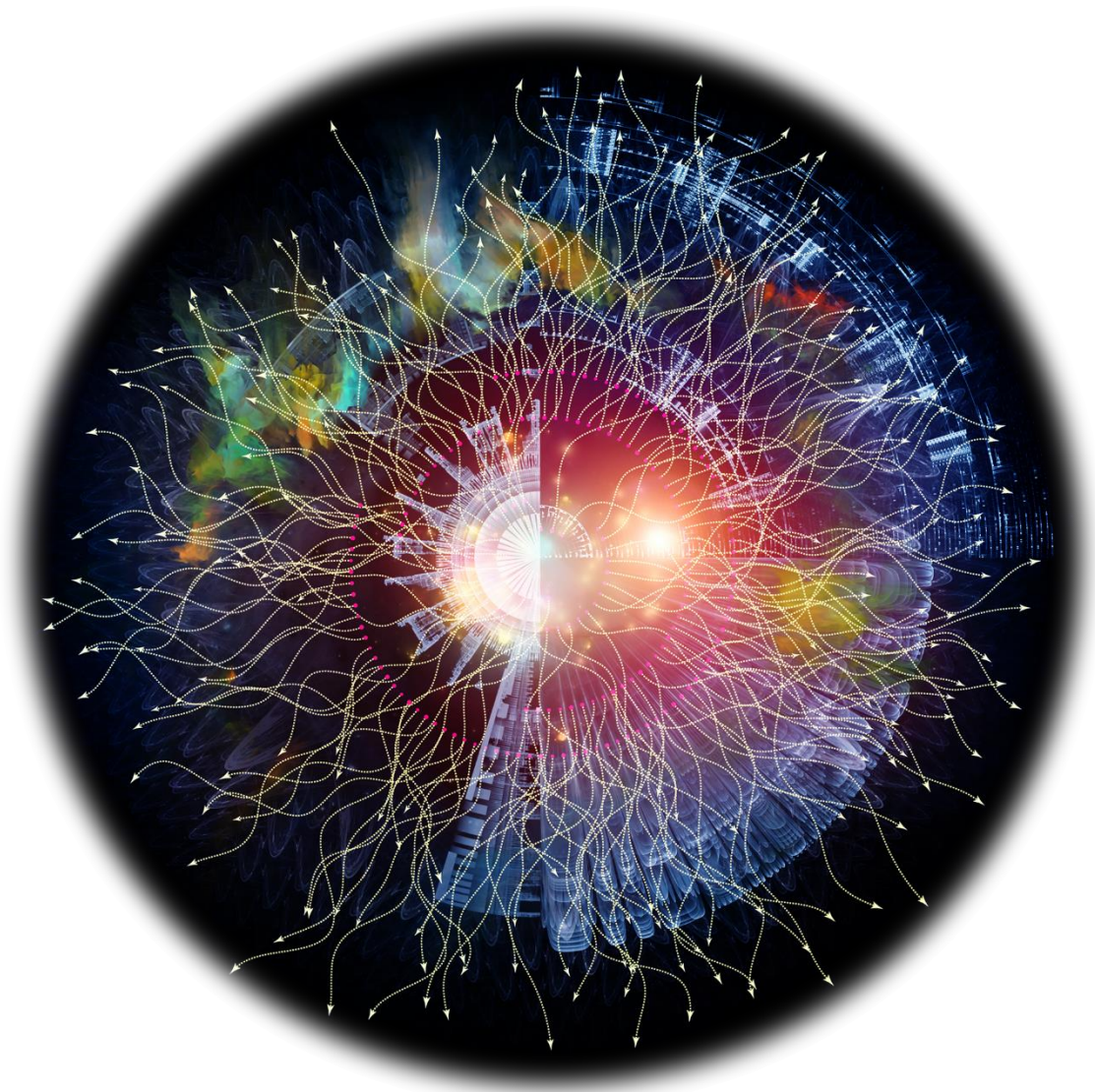

1 Service Pricing

1.1 Introduction to pricing

We offer a predictable all-in technology pricing model based on the hosted volume in our Relativity platform.

This pricing is based on the provision of a managed service and is provided on the premise that a Deloitte operations team will deliver the service.

All prices are quoted exclusive of VAT. The price quoted below is illustrative only and should not be used for budgeting purposes. We will work closely with you to agree the scope of your requirements before confirming the fee.

1.2 eDiscovery (eDisclosure) monthly per-gigabyte/per-user pricing

Our technology fees are offered based on a per-gigabyte-per-month (GB/Month) model and user account fees. Volume-based discounts are offered if the hosted data volume exceeds 100GB/500GB.

Notes to accompany the rate card consistent with G-Cloud 15 standards

The daily rates above are based on the following assumptions:

- The rates are exclusive of VAT
- A Working Day is eight hours exclusive of travel and lunch
- Working week is Monday to Friday excluding national holidays

- The rates are valid for the duration of Framework 1 – Initial Framework of G-Cloud 15 framework agreement
- The rates are subject to the availability of suitably skilled resources
- The rates are exclusive of expenses/travel and subsistence
- In situations where, by mutual agreement between Deloitte LLP and the Contracting Body, the rate card is used for Fixed Price deliverables, contingency may be added to reflect the requirements of such an arrangement
- The Contracting Body should treat the Charges and terms of an individual Call-Off Orders as commercially sensitive
- Professional indemnity insurance is included in the day rate

Here is a non-exhaustive list of hourly charged services:

- Forensic Data Collection – collecting the data for the purpose of ingesting and processing the data. Collections can be carried out both onsite or remotely.
- Data Processing - ingesting the data to be processed for extraction, deduplication, filtering, conversion, indexing and searching. Machine time is not charged. Only time spent on actual time spent on the work is chargeable.
- Review and Analytics Support
 - Indexing the documents, running searches, setting up rules/alerts and review workflows, creating policies, and other review/analytics support tasks
 - Time spent communicating to client, building reports, and hosting ad hoc training sessions are all chargeable
- Production, Data Transfer or Export
 - Tasks associated with producing or exporting documents for the purposes of disclosure, transfer or archiving
 - Data migration & loading of third party data. This refers to data processed by outside parties and is delivered with .dat file and in an agreed upon format.
