Definitions - Categories

Category	Definition
Strategy & architecture	Provide expert consultancy to translate business ambitions into actionable technical blueprints and roadmaps. It focuses on advising stakeholders on the best architectural choices to ensure the service is sustainable, compliant, and perfectly aligned with strategic objectives.
Business change	Identify, analyze, and document evolving business requirements and their impact on existing processes. Manage the end-to-end transition, ensuring that business needs are accurately translated into functional specs and that the organization is ready to adopt the resulting changes
Solution development & implementation	This category covers the end-to-end engineering of service features, from technical design and prototyping to live deployment. It focuses on building and integrating reliable, high-quality code into the production environment through structured development and testing cycles
Service management	This is the core of delivery, focused on maintaining service availability, performance, and security according to Service Level Agreements (SLAs). It includes proactive monitoring, incident response, and the management of routine operational tasks.
Procurement & management support	manages the underlying resources and third-party contracts (such as cloud providers or SaaS licenses) necessary to keep the service running. It ensures that the service delivery remains cost-effective and compliant with budgetary and legal constraints.
Client interface	serves as the primary touchpoint for service stakeholders, handling demand management and user feedback. It focuses on reporting service performance, managing customer satisfaction, and capturing new requirements to feed back into the service evolution
