Pricing overview

Fees comprise two elements - an implementation fee (year one only) and an annual licence fee based on the number of users (year one and onwards).

Implementation fee

This fee includes our time to work with you to establish the right configuration for your needs and commissioning of your version (including any internal development that may be needed). Implementation usually requires four or five days of our time - and after initial discussions about your requirements we will provide you with a fixed fee quotation based on a daily rate of £1,250.

Annual license fee

The annual licence fee includes hosting, support (for administrative users) and system upgrades.

Fees are changed based on the number of physical users who have access to the system. Within the system there is no limit to the number of owner names that can be created. Users can control multiple owner names.
