Pricing

1.1 INTRODUCTION

We aim to keep the pricing for LinkSpace Professional Standards simple and flexible. Pricing is shown in the tables below. All prices exclude VAT.

1.2 WHAT'S INCLUDED

We expect the price you see to be the price you pay for a fully-encompassing service, including full hosting, ongoing changes and support. Our support and software includes a very high level of service and available customisation. Whilst we do offer a separate consultancy service for specialist and bespoke requirements, we find that it is very much the exception rather than the rule.

1.3 MODULES

LinkSpace Professional Standards consists of 4 modules: Professional Standards; Intelligence & Anti-Corruption; Vetting; and Legal. All modules stand alone in their own right and can be used independently, or any number of modules can be combined in one system. Each system consists of one base system (which includes one module), with further modules added should they be required.

1.4 PRICING - SOFTWARE SUBSCRIPTION

The subscription costs for LinkSpace Professional Standards are based on the number of modules and users of a system as detailed in the tables below.

1.5 PRICING - IMPLEMENTATION

Ctrl O offers fixed implementation costs for routine migration, on-boarding and system deployment. This service includes basic data migration from clean and structured data source as well as a one-off initial training package. More complicated data migration and additional training is available as part of Ctrl O's separate consultancy services.

1.6 SUBSCRIPTION LENGTH, ADVANCE PURCHASE AND TERMINATION

A 30-day free trial is available and there are no termination costs. We encourage buyers to stipulate the contract may be terminated without cause by giving 30-days notice. Having established this flexibility we recommend the contract term is the maximum permitted under the framework.

Service is normally invoiced monthly in arrears (paid within 30 days). Optionally, and entirely at the buyer's discretion, we offer a, non-refundable, advance purchase discount of 5% for 12 months subscription.

1.7 CUSTOMER CLOUD HOSTING OPTIONS

While Ctrl O is partnered with ServerHouse for hosting services we recognise that customers may want or need to use alternative hosts. To ensure we can provide the same level of service, custom hosting (including on-prem and other cloud environments) can be supported for an additional £1150.00 per month, with any on-site visits additionally based on our cloud support services (Lot 3), daily rates.

1.8 OTHER CHARGES

There are no other charges for the use of the software, such as storage utilisation. Cloud support services (Lot 3) are available from Ctrl O covering all aspects of support of LinkSpace Professional Standards. Please look for "Consultancy in support of Ctrl O products" on the Digital Marketplace.
