Ending the contract without reason

If the Customer terminates the Call-Off Contract, all or part of it, before the Call-Off Contract end date, as set out in paragraph 13.2.2 of the General Terms, the Customer must give the Supplier no less than 90 days' notice.

The Buyer must promptly pay all outstanding Charges incurred to the Supplier and must pay the Supplier reasonable committed and unavoidable losses as set out in clause 13.5.3 of the General Terms. The Buyer will be Charged;

- 100% of any Monthly Recurring Charges remaining in the Minimum Period of Service;
- 75% of any Monthly Recurring Charges remaining in the second year of the Contract, and;
- 50% of any Monthly Recurring Charges remaining in the final year of the Contract.
